post Oak 12 - In dia bras N. $31\frac{1}{2}$ E. 100 bars
and a do 4 In dia bras S. 13 E. 53 bars -
Thence N. 45 E. at 1250 bars set a post for the
S. E. Corner from which a post oak 15. In dia
bras North 15 bars & a do 18 In dia bras S.
 80 E. 18 bars. Thence N. 45 W. at 120 bars en-
tered timber at 950 bars left timber and
entered prairie at 3200 bars a branch runs
