County of Brazos } Before me the Undersigned District Clerk In and for the County aforesaid, This day came and personally appeared Wm G Wilson a resident citizen of said County who being by me duly sworn declares that he is a bona fide settler upon 160 acres of vacant public land situated in said County and surveyed for Wm G Wilson on the 4 day of June 1857 John Seal Surveyor of said County that he has occupied and improved the same as a homestead for the period of three consecutive years beginning on the 4th day of June 1856 that he is head of a family and that he makes this affidavit for the purpose of obtaining a title to the same for a homestead under an act supplementary to "An act to regulate the disposal of the Public Lands of the State of Texas" Approved March 24 1871 and that he has not a homestead other than the above, and also at the same time came and personally appeared William King and William Reed two credible resident citizens of said County to me well known who being duly sworn de-

poss and says that Wm G Wilson
the person first above named in this
affidavit, has actually settled upon
and cultivated as a homestead the
land surveyed for him on the 4th
day of June 1856 by the Surveyor afore-
said, for the period of three years,
and they nor either of them have
any interest in the said land

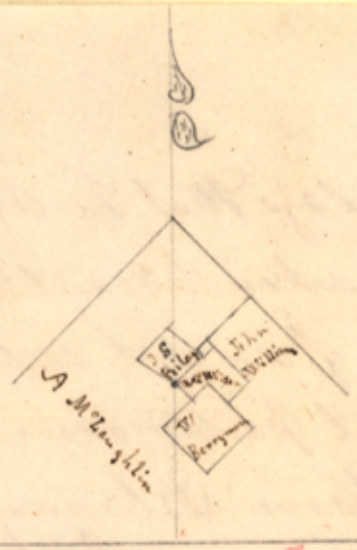
