of which is hereby acknowledged, have given and
bargained, sold and released, and do hereby
grant bargain sell and release unto the said
Jim Gurr his heirs and assigns forever, the
following described property, to wit: One hundred
and Sixty acres of a County Land Certificate
for three hundred and twenty acres of land
granted to P D McNeill for services in the army
of the Republic of Zetzu in the years 1835 &c.
Said certificate no 80 was issued by the
Court of Claims Sept 11th 1858 and transferred
by P D McNeill to Peter McGreal Oct 11th 1858
by act before Jas Dockrill Notary Public of
Bragoria County Zetzu, by Peter McGreal to Wm
Giblin March 20th 1859 before same Notary Public
By Wm Giblin to Chester A Bulley March 31st 1859
by act before Wm P Griffith Notary Public of
Harrison County Zetzu and by Chester A Bulley
to M A Mathews on the 9th day of June AD 1859
by act before T G Benner a Notary Public
of Cuyahoga County Zetzu all of which transfers
accompanying this deed will be delivered into
the possession of the said Jim Gurr
to have and to hold the same to the said
Jim Gurr his heirs and assigns free
from the claim or claims of all persons whomsoever
