attorney and agent, to ask, demand and receive from the Commissioner General of the Land
Office, or any other qualified officer of said Government, all Patents that I may be
entitled to from said Government, - for 36 acres of land my augmen-
tation H. K. Co of - Survey Co No 205 March 1st 1838 - located
on Spring Creek Harris County

and I do hereby authorize my aforesaid attorney, JACOB DE CORDOVA, to seal, sign and
deliver any instrument or instruments of writing that may be required, in the same manner as if
I were personally present: hereby ratifying all his acts in the premises.
