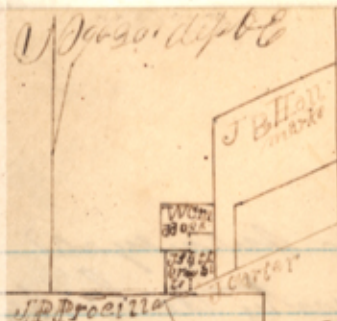

Located in Houston County about 9 1/2 miles S. 54° E. from Crockett

Beginning at the N.W. corner of Tno Tatters 80 acre Survey Pine tree S 54° W 1/2 was a Red oak tree S 1/2 E 2 was a dist. Thence with Patterwhite's line East at 449 was his corner an John B. Hall marks west boundary. Thence with Hallmarks survey North at 618 1/2 was corner from which a Post oak tree S 70° 00' 4 1/2 was Thence west at 10 1/2 was intersects boundary of M. Wardens survey. Thence S. with Wardens boundary at 99 8 1/2 was, where a Post oak tree N 7° E 5 1/2 1/2 was Thence East at 626 was intersects west line of Patterwhite's survey corner from which a Post oak tree S 87° E 9 3/4 was dist.
