William B. Gray his heirs and assigns all my Right
Title Claim and Interest in and to my Unconditional
head Right Certificate for three hundred and twenty
acres of land Issued to me by the Board of Land Com-
-missions for the County of Tyler Class 3rd No 83 and dated
the 18th day of Feb'y A.D. 1850, To have and to hold
the same to the own proper use and behoof of the
said William B. Gray his heirs or assigns forever.
And I, James Seals for myself my heirs executors
administrators or assigns. will warrant and
forever defend the above described Certificate
to the said William B. Gray his heirs executors
administrators or assigns against myself my
heirs executors administrators or assigns and
all and every other person or persons claiming
or to claim the same. And I, James Seals, do hereby
authorize and require the Commissioners of the Land
office of the State of Texas to Issue letters
Patent to above described Certificate. When lo-
-cated according to law. to the said William B. Gray
in his own name. and for his own proper use and
Benefit. In Testimony Whereof I have herunto set
my hand and Seal using a Serall for Seal at
Lyon Bluff in said County of Tyler this 34th day
