of land for which he applies is entitled  
to a conditional grant of Six Hun-  
dred and forty acres of land, in accor-  
dance with an act of Congress, approved  
January 4<sup>th</sup> 1841

Thomas of the County aforesaid for a valuable consideration to me in hand paid the receipt of which is hereby acknowledged, have this day bargained alienated transferred and conveyed and do by these presents bargain alienate transfer and convey unto Francis J. Duffau all my right title interest and claims to my head right certificate it being certificate No ~~Eight~~ <sup>Thirty Two</sup> fourth class for Six Hundred and Forty acres of Land and issued by board of Land Commissioners of Milam County on July the fourth 1842 as doth appear by certificate hereunto annexed And the said Duffau is to have and to use all the rights, powers and interests in the same that I myself could do and I the said Thomas do warrant and defend the said Duffau his heirs or assigns in the full use enjoyment and possession of said certificate against myself my heirs or assigns and all other persons

And I the said Thomas do hereby give & grant to the said Duffau all the rights and powers that I myself might have or use for the surveying locating and procuring patent on the said certificate and I do hereby ratify and confirm all and singular the acts and doings of the said Duffau touching the premises that he may deem necessary
