have this day bargained alienated and transferred  
and conveyed and do by these presents bargain  
alienate transfer and convey unto Francis J.  
Duffau all my right title interest and claim  
to my head right certificate it being certifi-  
cate No Thirty Three fourths class for three hundred  
Twenty acres <sup>of land</sup> and issued by the board of land  
commissioners of Milam County on the third day  
of February 1845 as doth appear by certificate here-  
unto annexed and the said Duffau is to have  
and to use all the rights powers and interests in the  
same that I myself could do and I the said Carter  
do warrant and defend the said Duffau his heirs  
or assignees in the full use enjoyment and possession  
of said certificate against myself my heirs or assi-  
gnees and all other persons —

And I the said Carter do hereby grant and give to  
the said Duffau all the right and powers that I  
myself might have or use for the surveying  
locating and procuring patent on the said
