THAT *Amos Daniel* having served faithfully and honorably for the term of *twelve* months from the *twenty third* day of *September 1834* until the *twenty third* day of *Sept 1837* and being honorably discharged from the *Army of Texas* is entitled to *twelve hundred eighty* Acres Bounty Land, for which this is his CERTIFICATE.

And the said *A Daniel* is entitled to hold said Land, or to sell, alienate, convey and donate the same, and exercise all rights of ownership over it:

This CERTIFICATE will be transferable by a deed before any competent authority, with witnesses to the same.

IN TESTIMONY WHEREOF, I have hereunto set my hand, at *Houston* COLUMBIA, the *twentieth* day of *January* 1838
