No. 462 UNCONDITIONAL.

Donald A. Mc Donald has appeared before us the Board of Land Commissioners for the County of Harris and proved according to law, that he arrived in this Republic prior to Jan'y 1st 1842 and that he has been a Resident Citizen up to the present time; that he is a single man, and therefore entitled to three hundred twenty acres of Land, to be Entered and Surveyed from any Vacant Land of the Republic. - made oath that he had never hitherto taken out his headright.

Given under our hands at Houston, this fifth day of August

1845

assigns to ratify and confirm whatsoever my said attorney
may lawfully do in the premises
