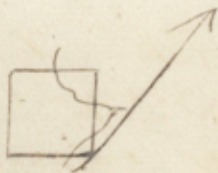

appoint the said John L Darragh my true and lawful  
attorney for me and in my name to call on the commissioners  
of the general Land office of the State of Texas for a patent  
for the above described Certificate in his own name  
as I have this day transferred to him the above described  
Certificate for six hundred and forty acres of Land
