to be Entered and Surveyed from any Vacant Land of the Re-

for 640 acres

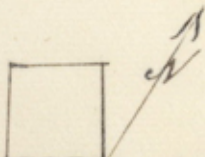

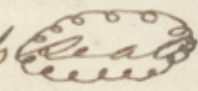

Hubby of the County of Milam and State aforesaid for and in consideration of sixty five Dollars to me in hand paid by him the said Caleb M. Hubby. My unconditional head right Certificate No 358 for six hundred and forty acres of land issued by the Board of Land Commissioners for the County of Harris and dated the seventh day of April 1845 To have and to hold the said certificate with all rights and privileges thereunto belonging to him the said C. M. Hubby his heirs and assigns forever free from the claims of one and my heirs and all persons claiming by Through or under me. I do further covenant and agree with the said C. M. Hubby that he has full power and authority to take out a patent on locations made on said Certificate in his own name and that I will warrant and forever defend the title to the same to him and his assigns free from the claim or claims of all and every person or persons.
