This is to Certify that John Lee
Lennon has appeared before us the
Board of Land Commissioners for the
County of Pulaski and a board according
to Law that he arrived in the Republic
on 28 Feby 1835; and that he is a
Single man and entitled to one third
of a League of Land upon an act of
paying at the rate of Three dollars⁵⁰
for every Salar of Prajall Land, Two
dollars⁵⁰ for each Salar of Temporal
a⁵⁰ another Land one dollar²⁵ for each
Salar of Pasture Land which may be con-
tained in the survey, within this territorial
