County of *Harrisburg* } Know all men by these presents:--

THAT *I Edward H Valentine* of the Town of *Houston* and County of *Harrisburg*, in the Republic aforesaid, for and in consideration of the sum of *three hundred* — Dollars to *me* in hand paid at or before the encasing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained and sold, assigned, transferred and set over unto *John Arden* of the Town of *Houston*

in the Republic aforesaid *his* heirs and assigns forever, all and singular my right, title and interest, property, possession, claim and demand in and to the *annexed* Certificate for *four hundred & eighty acres* of *county land issued by the Sec^y of War on the fifteenth of May 1838 and Number 3367* and to all and singular the

the four hundred and eighty acres of Land mentioned in the said Certificate to which the said *Edward H Valentine* the grantee in said Certificate mentioned was entitled. And I hereby, for myself *my* heirs, executors and administrators, fully guaranty to the said *John Arden his heirs* and *his* legal representatives the validity, legality and sufficiency of the said Certificate; and do further fully guaranty to the said *John Arden his heirs* and *his* legal representatives the obtaining, receiving and holding by a good, absolute and indefeasible title, the *four hundred and eighty acres* of Land, mentioned in the said Certificate—Hereby binding myself and my legal representatives, in default of the obtaining by the said *John Arden his heirs* or legal representatives, of a good and sufficient title to said Land as aforesaid under and by virtue of the said Certificate, to pay to the said *John Arden his heirs* or legal representatives, the full value of the said land as the same may be ascertained by appraisal, or according to the value of the Land of which but for such default in reference to said Certificate, he or they might have obtained the title and possession, together with any and all other damages *they* may sustain by reason of any defects whatsoever in the said Certificate.


