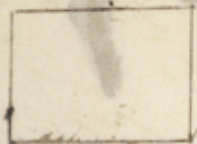

That Wyley Hunter having served faithfully
 and honorably in the Army of the Republic of Texas, for the term of
three Months, from the fourth day of June
1836 until the seventeenth day of
September 1836, and having enrolled for the
 term of two years and died in the service, his heirs
 are entitled to Nineteen hundred & twenty Acres
 Bounty Land, for which this is his CERTIFICATE.

And the said heirs of Wyley Hunter
 is entitled to hold said Land; or to sell, alienate, convey and donate the same; and to
 exercise all rights of ownership over it.

In Testimony whereof, I have hereunto set my hand, at Austin
 this twenty seventh day of August 1840.
