I know all men by these presents that I Gabriel Shirley for and in consideration of the sum of Twenty Dollars to me in hand paid, the receipt whereof is hereby acknowledged, have this day bargained, sold, transferred ~~alien~~ aliened, and conveyed, and do by these presents bargain sell transfer alien and convey unto William Lambins of the Republic and County aforesaid his heirs and assigns a Certificate for three hundred and twenty acres of Land, fourth class No 40 and issued by the Board of Land Commissioners for the County of Milam and dated the 3rd day of November eighteen hundred and forty five said Certificate being my own headright and the quantity of Land to which said Gabriel Shirley is entitled by law which will more fully appear by reference to the records of Milam County said Certificate is signed by John Gregg Chief Justice and officio President of the Board Land Commissioners for Milam County also by N. C. Raymond, Associate Justice for said County attested by S. A.
