Lewis* has appeared before us, the BOARD OF LAND COMMISSIONERS FOR THE COUNTY OF GALVESTON, and proved according to law that he emigrated to the Republic of Texas ~~in~~ ^{previously} the month of *January* A. D. 1842 that he resided in and was an actual citizen of said Republic three years and performed all the duties required of him as a citizen, that he is a *single* man, and that he has never heretofore obtained a certificate or headright for land. He is therefore entitled to an unconditional grant of *Three* hundred and *twenty* acres of LAND in accordance with an act of Congress approved 16th January, A. D. 1843

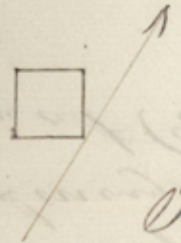
