The said Bollinger admin as aforesaid having presented the Conditional Certificate of said Ellis deceased, issued by the Board of Land Commissioners of Bastrop County of date January 4th 1839 - and also having proved that said Ellis complied with the conditions of said Conditional Certificate and was at the time of his death a citizen of Texas. -
