This is to Certify that ~~Some~~ Jonathan C. Bullock,  
has appeared before us the Board of Land Commissioners for  
the County of Washington and proved according to Law  
that he arrived in this Country in November of the  
Year Eighteen Hundred and Thirty four, that he is  
a Single man, and entitled to One Third of a  
League of Land, Upon the Condition of paying at  
the rate of Three <sup>50</sup>/<sub>100</sub> dollars for every Labor of Irrigable  
Land, Two <sup>50</sup>/<sub>100</sub> dollars for every Labor of Grable or Tem-  
poral Land, and One <sup>20</sup>/<sub>100</sub> dollar for every Labor of  
Pasture Land which may be contained in the Survey  
Secured to him by this Certificate - Given under our  
hands this Sixth day of September 1838

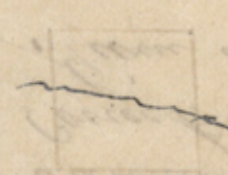
