my donation Certificate No 183 for 640 Acres of
Land Granted to me by the Republic of Texas
for having fought at San Jacinto April 21, and
1836 dated Houston 23rd day of May 1838
Signed Barnard Bee Secy of War
and defraying all and singular any
expenses incident to Locating and Patent-
ing Said Certificate do by these presents
Give Grant and Transfer to Said Duffau
Six Hundred and Thirteen and one third
of acres of Said Certificate to be by Said
Duffau Located and Surveyed by Said
Duffau on any of the public domain
he may select and to use and exercise
all acts of Ownership over the Same as if
acquired by a Good General Warranty
Title and I Said Cross for myself my
heirs and assigns do agree to defend
Said Duffau in the full use and
enjoyment of Said Land so Located
viz 2 1/3 Acres or One Third of Said Six
Hundred and forty Acres against the
Lawfull Claims or Claims of myself
my heirs executors or assigns and against
the Lawfull Claim of all persons claim-
"ing the Same by through or under me

at Cameron this 28th day of ^{April} ~~July~~ 1848
