John Phillips has appeared before us the Board of Land Commissioners for the County of Harris and proved according to law, that he arrived in this Republic prior to 1st October 1837 and that he has been a Resident Citizen up to the present time; that he ~~is~~^{was} a single man, and therefore entitled to six hundred forty acres of Land, to be Entered and Surveyed from any Vacant Land of the Republic. Conditional Certificate for 640 acres issued in Harris Co. dated Dec 6. 1838. No. 1048.
