This is to certify that Heil O Campbell
has appeared before us the board of Land Commis-
sioners of the county of Austin and proved
according to law that he arrived in this coun-
try in the year eighteen hundred twenty eight
and that he is a single man and that he is enti-
tled to one labor of land as a part of his land rights
upon the condition of paying at the rate of
3 Dollars 50 cents for every labor of irrigable
land of 2 Dollars 50 cents for every labor of
temporal or arable land and of 1 Dollar
20 cents for every labor of pasture land
which may be contained in the survey secured to
him by this certificate.

this 3th day of March 1838.

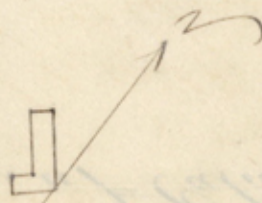

3^d. day of March 1838, as a part of
my headright, and signed at San Felipe
de Austin on the above day by Robert
Kliberg and J. La Fayette Hill associate
Commissioners and attested by Louis Kliberg
Clerk of the Board; And I hereby in-
vest the said Lee with all the right &
title which I had in and to the same, in
order that he may possess, use or dispose
of the same as he may see proper; hereby
binding myself, my heirs and administrators
to warrant and defend the same unto the
said John C. Lee or his agent or assigns.
