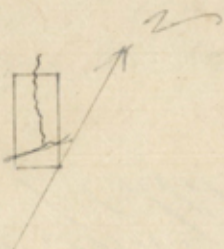

Know all men by these presents that I Solomon Fulsher of the County afore said For and in consideration of the Sum of Twenty five dollars to me in hand paid By Frederick Reibling of said County the receipt there off is hereby acknowledged Have this day Bargained and Sold and by these presents do bargain and Sell Convey and release unto the said Reibling his heirs and assigns all my right title and interest in and to a Certificate <sup>No 46</sup> of Land for three hundred and twenty acres of Land Granted to me by the Board of Land Commissioners for the County of Milam according to law Granting Land to Emigrants Being no 4<sup>th</sup> Class Hereby relinquishing all my Right title and interest that I have in the Same or would acquire by the location of the Same to the said Reibling his heirs and assigns hereby giving him full possession of the said Certificate to have the same located when and where he may please upon the vacant Land of the Republic and all right Ceded by the Government when located Together with all and singular the ways woods waters water courses Rights Liberties Priviledges Hereditaments and appurtenances what so ever there unto belonging or in any wise appertaining to the only use and behoof of the said Reibling his heirs or assigns for Ever The Commissioner of the General Land office is authorized to Issue the Patent to said Reibling as Assignee if the laws will permit the Same I Bind my Self my heirs to the said Reibling his heirs and assigns in the fore going premises against all Person or Persons Claiming will for Ever warrant and defend Where unto I have set my hand and seal this the 10 day of Decr 1845
