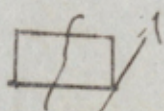

Survey for L. Vibling assignay of Lewis Ryan of 320 acres of land situated on the east fork of the bosque river and being the quantity of land to which he is entitled by virtue of certificate No 45 of Class issued in Milam County

Beginning at the N.W. corner of the survey made for Wm H. Smith for the S.W. corner of this survey from which a Mulberry tree marked F bears S 24 E. 157 yards running from thence N 30 W. 950 yards to the W.W. corner of this survey from which a live oak marked F bears S 15 W 36 yards and another mark W & N bears N 36 E. 8 yards thence N 60 E. through post oak 1500 yards crosses the east prong of the bosque and enters prairie 1900 yards to the N.E. corner thence N 30 E. 950 yards to a mound for the S.E. corner thence S 60 W. recrossing bosque 1900 yards to the beginning

land paid by L. Veibling of Milam
County the receipt thereof is hereby ack^d
noted & have granted bargained
sold and conveyed unto said L.
Veibling his Heirs and assigns
all my right title and interest
in my headright certificate No 45
Class 4 issued in Milam County dated
3 noons 1845 with all the benefit
lands and privileges therefrom arising
relinquishing all claim to the land
it being 320 acres unto said L. Veibling
his Heirs and assigns forever and
the said said Veibling to locate
at his pleasure the said certificate
and at his expense and demand and
receive a patent from the proper
officers of government and use as
his property in any wise
