been engaged in the storming of Fort Mifflin during that time,
is entitled to three hundred and twenty Acres
Bounty Land, for which this is his **CERTIFICATE.**

And the said Ralph M. Lee
is entitled to hold said Land, or to sell, alienate, convey and donate the same; and to exercise all rights of ownership over it.
