

being by me duly sworn, declares
that he is a bona fide settler on
160 acres of vacant Public land
situated in said County, and sur-
veyed for him on the 10th September
AD 1872. by E. A. Scutchfield, Surveyor
of said County; that he has occupied
and improved the same as a home-
stead, for the period of three con-
secutive years, beginning on the
21st day of Feb^ruary, 1871. and that
he is now on said land, and that
he makes this affidavit for the
purpose ^{an} of obtaining a title to the
same for a homestead, under an
Act for the benefit of actual occupants
of the Public Lands, approved May 26th
1873, and that he has not a homestead
other than the above.
