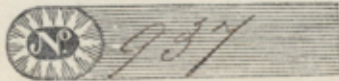

appeared before us, and proved according to Law that he emigrated to Texas previous to the 1st Oct 1837. & died therein that he received a Conditional Certificate from the Board of Commissioners of Harrisburg Co. for 240 acres N. 160 dated ~~17th~~ March 17th 1838, Chap. 2,

This is therefore to declare that the said *Prentiss Clwell* *deceased*, by his administrator - is entitled to an Unconditional Headright of *six hundred & forty* Acres, by virtue of his emigration, and the above described Certificate heretofore issued.

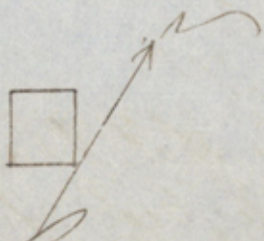
