part, the receipt of which is hereby fully acknowledged and confessed, the said party of the first part, by this act, has granted, bargained, sold, conveyed and released, and doth hereby grant, bargain, sell, convey and release unto the said party of the second part, his heirs, assigns and legal representatives, the following described land and premises, lying and being situated in the County of Bosque in the State of Texas.

To wit: Eighty acres of Land situated in Strip Out of Land Script No 18/209 dat January 13th 1863 which was issued to me as the original said Eighty Acres being the same portion as was located by D B Scott on the Headwaters of Chilares Creek and known as Survey No 1044. for a more particular identification of said strip difference is hereby made to file 818 Milam Script s

Together with all and singular the rights, members, improvements, hereditaments and appurtenances to the same belonging or in any wise incident or appertaining, and the reversions and remainders, rents, issues and profits thereof. To have and to hold all and singular the premises and hereditaments above mentioned and hereby and herein granted, with the appurtenances thereto belonging, to the said party of the second part, his heirs and assigns, to the only proper use and behoof of the said party of the second part, his heirs and assigns for ever. And the said party of the first part by this act bind himself his heirs, executors and administrators, to warrant and for ever defend all and singular the said herein before described premises unto the said party of the second part, his heirs and assigns, against every person or persons whomsoever lawfully claiming or to claim the same, or any part thereof.

In witness of all which, the party of the first part hereunto set his hand and seal (using scroll for seal,) at Austin  
this 13th day of January in the year of our Lord one thousand eight hundred and forty three
