an honorable discharge from the Army of Texas
after a service of three months and received as a
compensation a right to three hundred and twenty
acres of land as will appear by the annexed
Certificate being numbered 266 and bearing date
the 6th day of ~~October~~^{December} 1836, and having
by law the right to the said three hundred
& twenty acres of land as will appear by the
said Certificate with full power in me vested
to transfer the same by deeds or to exercise all
right of ownership over it or to sell alienate
convey and donate the same as will be fully
seen by reference to the said Certificate; and the
said William G. Evans hereby declare and
make known that I have never sold alienated
transferred or mortgaged the said three hundred
and twenty acres of land granted by said cer-
tificate or any part thereof but that the whole
right to the said three hundred and twenty (320)
acres of land is to this date a vested right belong-
ing to me by virtue of the laws of the Republic of
Texas.

Now therefore be it known that I the said

William G. Erant for and in consideration of the sum
of Two hundred Dollars Cash to me in hand paid by
Chas^r A Pearson & John R Horde (Citizens of the town
of Newton) the receipt whereof is hereby confessed and
acknowledged, I have granted bargained & sold to the
said Chas^r A Pearson & John R Horde the said three
hundred and twenty acres of land and by these
presents I hereby transfer all right title and in-
terest in and to the said three hundred and twenty
acres of land to the said Chas^r A Pearson & John
R Horde their heirs assigns or successors and with
this deed I deliver over to them the said certificate
with a legal transfer all of which is herunto attached
And I hereby declare that all right to the said three
hundred and twenty acres of land conveyed to me by
the said certificate is by virtue of this deed for the
consideration aforesaid made the absolute property
of the said Chas^r A Pearson & John R Horde their
heirs assigns or successors forever and as the own-
ers of the said land granted by the said certifi-
cate they the said Chas^r A Pearson & John R Horde
are authorized to locate, survey, demand and
receive a title in their own proper names as fully
as I could do before this sale as the whole property
in land and certificate aforesaid is hereby fully
vested in them and they are hereby authorized to

we enjoy and dispose of the said land as their own
property acquired by a just and legal title. I renounce
the law Non numerata Pecunia ^{no} Entrega, Pruecia
and bind myself my heirs executors administrators
and assigns to make good this sale to the pur-
chasers and for the security of the purchasers
I hereby bind my property present and future to war-
rant and defend this sale and transfer as
stipulated, and submit to the tribunals in order
that they may compell performance,
