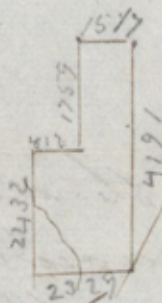

of a Decree of the District Court of Grayson County  
rendered at the Fall Term of the said Court for  
the year 1879

Eastwood his heirs & assigns forever the said  
aforesaid League & Labor of Land described as  
aforesaid together with all the rights, privileges &  
appurtenances thereto belonging, hereby warranting  
& defending unto the said Eastwood <sup>the</sup> said  
title and is vested in me in virtue of the Power  
of Attorney above described & the Decree of the Court  
aforesaid In witness whereof I have signed  
these presents the 15th day of July 1881 in presence  
of Witnesses & placed my Seal by way of Seal
