



the said party of the first part, by this act has granted, bargained, sold, conveyed and released,  
and doth hereby grant, bargain, sell, convey and release unto the said party of the second part,  
his heirs, assigns and legal representatives, the following described land and premises, lying  
and being situated in the County of Mc Lellan in the State of Texas. To wit:

One third League of Land the Headright of Estevan  
Villareal. granted by District Court of Bexar County  
to W Richardson assignee of Estevan Villareal. together  
with the Land thereby secured and Surveyed on the waters  
of the Brazos River and I do hereby authorize the Com-  
missioner of the General Land office to issue the Patent to  
the said John S Andrews in his own name.

Together with all and singular the rights, members, improvements, hereditaments and appur-  
tenances to the same belonging or in any wise incident or appertaining, and the reversions and  
remainders, rents, issues and profits thereof. To have and to hold all and singular the  
premises and hereditaments above mentioned and hereby and herein granted, with the appurtenan-  
ces thereto belonging, to the said party of the second part, his heirs and assigns, to the only

proper use and behoof of the said party of the second part, his heirs and assigns for ever. And the said party of the first part by this act bind himself his heirs, executors and administrators, to warrant and for ever defend all and singular the said herein before described premises unto the said party of the second part, his heirs and assigns, against every person or persons whomsoever lawfully claiming or to claim the same, or any part thereof. *by through or under the party of the first part*

In witness of all which, the party of the first part hereunto set his hand and seal (using scroll for seal,) at Houston this 28<sup>th</sup> day of October in the year of our Lord one thousand eight hundred and fifty three
