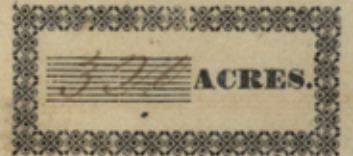

THAT *Nicholas Brown* having served faithfully and honorably for the term of *Three* months from the *twenty 5th* day of *June* 1836 until the *Five* day of *Oct 1836* and being honorably discharged from the *Army of Texas* is entitled to *Five hundred & twenty* Acres Bounty Land, for which this is his CERTIFICATE.

And the said *Nicholas Brown* is entitled to hold said Land, or to sell, alienate, convey and donate the same, and exercise all rights of ownership over it:

This CERTIFICATE will be transferable by a deed before any competent authority, with witnesses to the same.

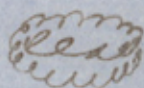
