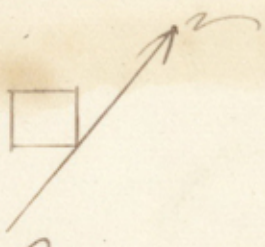

the legislature granting Preemp-
tion privileges to actual settlers
which was legally surveyed - by the
Deft. Surveyor - G. B. Erath - on the
4th of Nov. A. D. 1853 -

enjoy - and receive a patent in
his own name - and I bind
myself to forever defend the
same from myself or any person
