of 520 acrs. of land made
for Abner Pitcher, it being the
quantity of land to which he is entitled
by virtue of Certificate No 523 issued
by the Board of Land Commissioners
of Lavaca County on the 15th day of
May 1854. Said land is situated in
Bosque County below the mouth of Steel
Creek 1/2 mile from the Brazos River opposite
Fort Graham. and about 12 miles N. & E. from Meridian;

Beginning at the N^W corner of a
Preemption Survey made for Phillip Howard
for the N^E corner of this survey a mound
in the prairie thence S 60^o W 1900 varas to
the N^W corner from which a Post oak
3 inches in diameter bears S 85^o E 700 and
another 3 inches in diameter bears S 30^o W 4/5
or thence S 30^o E 950 varas to the S^W corner
from which a Post oak 15 inches in diameter
bears S 25^o E 3 varas another 12 inches in diameter
bears N 70^o E 700 thence N 60^o E 1900 varas
to the S^E corner from which a Cedar 12 in
in diameter bears S 62^o W 16 varas thence
N 50^o W 950 varas to the beginning. Surveyed
