appeared O Knutson a resident Citizen of said
County who being by me duly sworn declares
that he is a bona fide settler upon one
hundred and sixty acres of vacant public
land situated in said County and surveyed
for O Knutson on the — day of October
1869 by Ward Keeler Surveyor of said
County that he has occupied and improved
the same as a homestead for the period of
three, ^{consecutive} years beginning on the — day of May
1869 that he is A Married man and that he
makes this affidavit for the purpose of obtaining
a title to the same for a homestead under an act
supplementary to an act to regulate the disposal
of the Public Lands of the State of Texas approved
March 24th 1871 and that he has not a homestead
other than the above; And also at the same
time came and personally appeared A Nelson
and J Grimland two credible residents Cit-
- zens of said County to me well known who
being duly sworn depose and say that O
Knutson the person first above named in
this affidavit has actually settled upon
and cultivated as a homestead the land
surveyed for him on the — day of October
A D 1869 by the surveyor aforesaid for the

period of three years and they nor either
of them have any interest in the said
land

E. corner of this, a Live Oak marked T bears N 5⁰ E 26 vars another marked u bears N 34⁰ W 31 vars Thence S 60⁰ W 672 vars to the N. W. corner on the mountain Thence S 30⁰ E 1344 to the S. W. corner in the ^{N. W.} of **K** Helton's line Thence N 60⁰ E 672 vars to the S. E. ^{of this survey} Thence N 30⁰ W 1344 vars to the beginning.
