

and that a writ restitution issues therefor
and that execution may issue for costs
accrued in the above intitled Cause
Writ of restitution issued to W. C. Lang Constable B.C.T.
on the 24th day of April 1889
returned on the 20th day of June 1889
with following indogment executed on the
24th day of April 1889 by dispossessing
Gunder Olsen and putting Ole Hagen
in possession of said Land W. C. Lang Constable
B.C.T.

a resident citizen of said County, who being by me duly sworn, declares that he is a bona fide settler upon One Hundred & twenty acres of vacant public land, situated in said County, and

surveyed for Gilbert O. Olson on the 15 day of March 1879 by Jas M. Robertson a Surveyor of

said County; that he has occupied and improved the same as a Homestead for a period of three consecutive years, beginning on the 6 day of July 1877

that he is Married man and that he makes affidavit for the purpose of obtaining a title to the same for a Homestead, under an Act supplementary to "An Act for the Benefit of Actual Occupants of the Public Lands," approved May 26th, 1873, and Acts prior thereto; and that he has not a Homestead other than the above.

AND also at the same time came and personally appeared John Christiansen and Anton Olson two credible resident citizens of said County, to me

well known, who being duly sworn, depose and say that Gilbert Olson the person first above named in this Affidavit; has actually settled upon and cultivated as a

Homestead, the land surveyed for him on the 15 day of March 1879 by the Surveyor aforesaid, for the period of three years, and they nor either of them have any interest in the said land.


