

It is there fore ordered adjudged and decreed by the Court that the said patent be and the same is hereby cancelled and held for naught, and that t thecloud cast upon the Defendants title by reason of said pater be and the same is hereby removed, it is futherordered by the Court that execution issue in favor of the officers of Court against each party respectively for all costs by them in this


