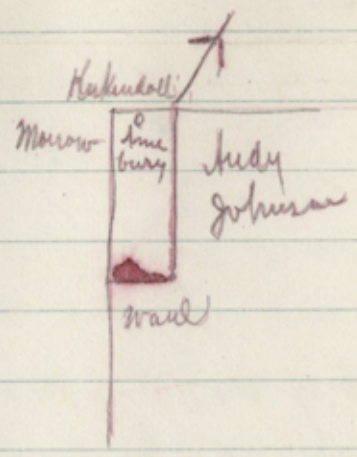

PROOF OF SETTLEMENT UNDER HOMESTEAD ACT.

The State of Texas,

County of Bosque

BEFORE ME, the undersigned, County Clerk in and for the County aforesaid, this day came and personally appeared Ole Arneberg, a resident citizen of said County, who being by me duly sworn, declares that he is a *bona fide* settler upon 5.0 acres of vacant Public Land, situated in said County, and surveyed for him on the 12th day of March 1880, by James M. Robertson a Surveyor of said County; that he has occupied and improved the same as a Homestead for a period of three consecutive years, beginning on the 15th day of March 1880, that he is Married man, and that he makes this affidavit for the purpose of obtaining a title to the same for a Homestead, under "An act for the Benefit of Actual Occupants of the Public Lands," approved May 26^h, 1873, and Acts prior thereto; and that he has not a Homestead other than the above.

And also at the same time came and personally appeared John Rastad and M. P. Ruison, two credible resident citizens of said County, to me well known, who being duly sworn, depose and say that Ole Arneberg, the person first above named in this Affidavit, has actually settled upon and cultivated as a Homestead the land surveyed for him on the 12th day of March 1880, by the surveyor aforesaid, for the period of three years, and they nor either of them have any interest in the said land.
