### PROOF OF SETTLEMENT UNDER HOMESTEAD ACT.

The State of Texas,

BEFORE ME, the undersigned, County Clerk in and for the County aforesaid, this day came and personally appeared B. A. Rogstad a resident citizen of said County, who being by me duly sworn, declares that he is a *bona fide* settler upon Eighty acres of vacant Public Land, situated in said County, and surveyed for B. A. Rogstad on the 20<sup>th</sup> day of August 1884, by Peter Pierson *Special Dpt for S. J. Hiddale* Surveyor of said County; that he has occupied and improved the same as a Homestead for a period of three consecutive years, beginning on the 15<sup>th</sup> day of December 1884, that he is married man, and that he makes this affidavit for the purpose of obtaining a title to the same for a Homestead, under "An act for the Benefit of Actual Occupants of the Public Lands," approved May 26<sup>th</sup>, 1873, and Acts prior thereto; and that he has not a Homestead other than the above.

And also at the same time came and personally appeared B. A. Rogstad and Jas. H. Knight, two credible resident citizens of said County, to me well known, who being duly sworn, depose and say that B. A. Rogstad, the person first above named in this Affidavit, has actually settled upon and cultivated as a Homestead the land surveyed for him on the 20<sup>th</sup> day of August 1884, by the surveyor aforesaid, for the period of three years, and they nor either of them have any interest in the said land.
