And the said *A Montgomery* is entitled to hold said Land, or to sell, alienate, convey and donate the same, and exercise all rights of ownership over it:

This CERTIFICATE will be transferable by a deed before any competent authority, with witnesses to the same.

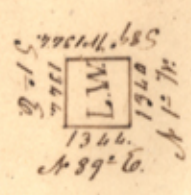
