half or 160 acres of Rufus P. Rice's headright
Certificate No. 183, Granted by the Board of Land
Commissioners for Robertson County on the 11th day
of October 1847, for 320 acres of land. Do have and
do hold unto the said McCouston his heirs & assigns

forever. All to many whereof I have borne to
my hand and scrawl as witness the
10th day of August 1853.
